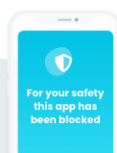
## TSC Content Filter - Qustodio Parent Account/App

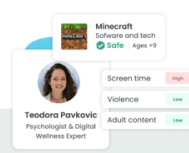
You can now use the Qustodio Parents' App to ensure digital safety and balance for your children.



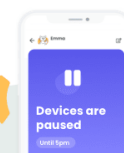

Dear Parent/Guardian:

Last fall, the TSC was forced to implement a new internet content filter (Linewize). Our previous content filter (Securly) offered a parent account/app that many had come to appreciate. This has been missed since the transition away from Securly.

Linewize has been working to provide a parent account/app that integrates with their content filter. Rather than designing a parent option from the ground up, they've opted to partner with an existing company (Qustodio) to offer a school-sponsored solution that provides parents/guardians with oversight of their child's internet activity when using their school-issued device. Through this service, parents/guardians can also add up to two of their students' personal devices (optional) to their Qustodio account, free of charge. TSC will have no access to usage data for those devices.

The Qustodio parent account/app provides the following options to parents/guardians:

- Ensure your child's safety and wellbeing online after school hours
- Gain visibility and insights on how school devices are being used

- Pause internet access to balance your child's digital activity based on the parameters set up by your district
- Receive expert advice and insights on online safety topics like cyber bullying, screen time, gaming and trends
- *More features coming soon*, including more detailed reporting and the ability to block specific websites when your student isn't at school. We are aware the reporting options aren't as robust as what was offered with the Securly parent option. Linewize and Qustodio have assured us that enhancements are coming in the very near future.

The Qustodio parent account/app will provide parents/guardians with the above information for students in **grades 2-12** (students using Chromebooks).

To begin using Qustodio, please visit [qustodio.com/my-school](https://qustodio.com/my-school) and follow the prompts to activate your account. **You must use the same email address that is used for your PowerSchool Parent Portal account.**

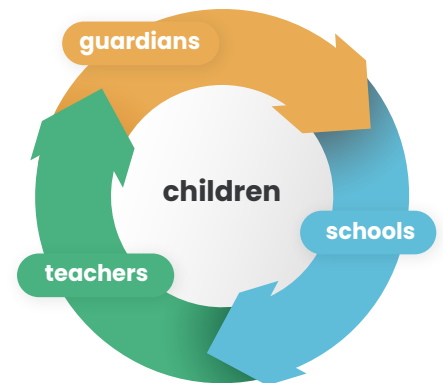

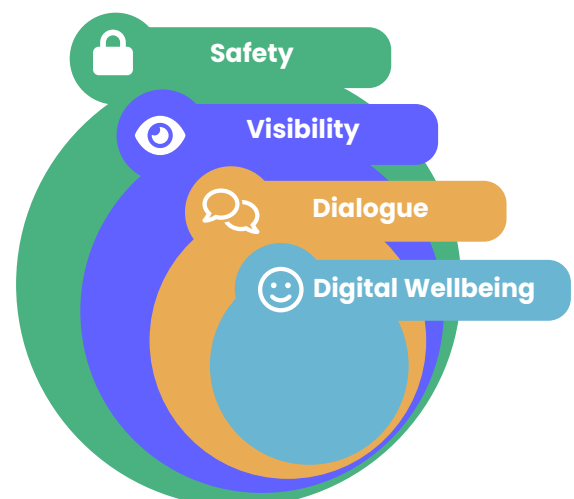



# App for Parents & Families






